Cigna Preferred Medicare (HMO) has a network of doctors, hospitals, pharmacies and other providers. If you use the providers that are not in our network, the plan may not pay for these services.

You must generally use network pharmacies to fill your prescriptions for covered Part D drugs.

Your prescription drug copay will typically be less at a preferred network pharmacy because it has a preferred agreement with your plan.</p> <p>You can get your prescription from an out-of-network pharmacy, but may pay more than you would pay at an in-network pharmacy. If you reside in a long term care facility, you would pay the standard retail cost-sharing at an in-network pharmacy.</p> <p>Your costs may be different if you qualify for Extra Help. Your copay or coinsurance is based on the drug tier for your medication, which you can find in the plan <i>Comprehensive Prescription Drug List</i> on our website CignaMedicare.com. Coverage Gap	<p>Most Medicare prescription drug plans have a Coverage Gap (also called the Donut Hole). This means that there is a temporary change in what you will pay for your drugs. The Coverage Gap begins after your total yearly prescription drug cost (including what our plan has paid and what you have paid) reaches \$4,130. Not everyone will enter the Coverage Gap.</p> <p>After you enter the Coverage Gap, you pay 25% of the plan's cost for covered brand name drugs and 25% of the plan's cost for covered generic drugs until your costs total \$6,550, which is the end of the Coverage Gap.</p> <p>This plan offers some additional prescription drug coverage for Tier 1 drugs in the Coverage Gap.
